## What You Need to Know about Overdrafts and Overdraft Fees

An <u>overdraft</u> occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. In this situation, you can ensure your transactions are paid under one of the following methods:

- 1. We have <u>standard overdraft protection</u> that comes with your account.
- 2. We also offer an <u>alternative service for covering overdrafts</u>, such as a link to another account, which may be less expensive than our standard overdraft protection. To learn more, ask us about this service.

This notice explains our standard overdraft protection.

#### > What is the standard overdraft protection that comes with my account?

We may authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We <u>do not</u> authorize and pay overdrafts for the following types of transactions unless you opt-in to full overdraft protection:

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transaction. If we do not authorize and pay an overdraft, your transaction will be declined.

#### What fees will I be charged if Reliance State Bank <u>does not pay</u> my overdraft?

We may charge non-sufficient funds (NSF) fees of up to **\$30** upon each presentment. Third party merchants may charge their own returned item fees as well.

### > What fees will I be charged if Reliance State Bank <u>pays</u> my overdraft?

Under our standard overdraft protection:

- We may charge you a fee of up to \$30 each time we pay an overdraft.
- We may charge you up to \$150 per day for overdrawing your account.
